

# CHECKLIST FOR PAKISTANIS

Generally, the Embassy of India issues a visa valid for 3 months, single entry. This visa cannot be exchanged or renewed in India. Nonetheless, your passport must be valid for at least 6 months.

## LIST OF DOCUMENTS FOR PAKISTANI PASSPORT HOLDERS

- 1 Original passport valid for a minimum of 6 months and having at least 3 blank visa pages
- 2 A photocopy of the data page of the passport
- 3 The service fees, additional consular charges and the visa fees

**Seven (7) identical files must be made with the following documents in this order:**

- 1 A special « Pakistan » visa application form that must be collected from our visa application centre in Paris. Each copy must be hand filled (photocopies not accepted).
- 2 A photograph conforming to prescribed specifications pasted on the application form
- 3 The hand filled reference form for Pakistanis (in block letters, photocopies not accepted)
- 4 Copy of a valid French resident permit
- 5 A detailed description of the proposed journey and itinerary in India
- 6 A recent work attestation from your employer in your name
- 7 For minors: photocopy of the French livret de famille (pages: father, mother, relevant child)
- 8 For minors: authorisation letter for a minor to travel signed by both parents and their ID proof

## LIST OF DOCUMENTS FOR APPLICANTS OF PAKISTANI ORIGIN

- 1 Original passport or travel document valid for a minimum of 6 months and having at least 3 blank visa pages
- 2 A photocopy of the data page of the passport
- 3 The service fees, additional consular charges and the visa fees

**Two (2) identical files must be made with the following documents in this order:**

- 1 A visa application form duly filled in online and signed by the applicant
- 2 A photograph conforming to prescribed specifications pasted on the application form
- 3 The hand filled reference form for Pakistanis (in block letters, photocopies not accepted)
- 4 For non-French passport holders: copy of a valid resident permit
- 5 For minors: photocopy of the French livret de famille (pages: father, mother, relevant child) or birth certificate
- 6 For minors: authorisation letter for a minor to travel signed by both parents and their ID proof

Optional documents that may contribute to speed up the processing of your application:

- For members of International Organisations (United Nations, World Bank, International Monetary Fund...): letter from the institution explaining the necessity for the applicant to visit India
- Documents proving that the applicant is married to an Indian national or a person of Indian origin
- Documents proving that the applicant has strong family ties in India

I hereby certify that I have submitted a complete application and that I know and accept the minimum processing times required for my visa application.
